Board of Deacons

The role of Deacons, as defined by the Book of Order is "a ministry of caring; a ministry of love; a ministry of compassion; and a ministry of prayer, and community service (G-6.0402)

During the 2016-2017, the Deacons worked to fulfill existing ministries, to identify and implement new ministries, and to offer training to equip Deacons for this important role.

Structure: Deacons are divided into 4 service groups with specific assignments.

- Immediate Care: To respond to each family on the Prayer list with contact to offer prayers and determine if any other care is needed (meals, rides, visits)
- Member/Continuing Care: To provide prayer and care to families with longer-term or chronic concerns, including sending notes and sending a set of grief books to bereaved families.
- New Member Care: To encourage membership in FOPC and to support new members during their entry into the church.
- Hospitality: To provide beverages and food before and after worship. To provide food and beverages during special events, such as funerals.

Meetings: Deacons meet monthly to pray, to discuss congregational needs and new ideas for service, and for training in important skills for Deacons.

2016-2017 Activities

- Developed an **Annual Plan** which included
 - o Monthly reports from each service group
 - o "Deep dive" reports from one service group each month
 - Specific training topic for each month
 - Hands-on activity at each meeting
- Fulfilled Regular Roles
 - Immediate Care contacted those on the Prayer list, always offering prayer, and providing other services as appropriate, including bread for newly bereaved members, and meals for families in short-term or long-term need
 - Continuing Care sent notes to members requesting prayers, sent grief books quarterly to those in the first year of loss, and maintained contact with those needing long-term care
 - New Member developed and maintained the kiosk and materials for visitors at the front entrance, as well as developing a new format (MATCH) for prospective new members meetings, then hosting a successful MATCH meeting and a new member orientation.
 - Hospitality provided coffee and snacks before and after worship every Sunday during the year. Tasks included shopping for food and beverages, making coffee, set up and clean up each Sunday.

 - Provided Books on Deacon Skills to all Deacons
 - o Trainings:
 - Understanding and Meeting Need

- Confidentiality
- Do's and Don'ts for Listening and Comforting
- Welcoming the Newcomer (guest speaker Tina Lewis)

 - Gift packs to staff in gratitude
 - Valentine gifts to college students
 - Cards to homebound members
 - Distributed Easter flowers to homebound
 - Graduation cards
- o Reception Planning and Participation (in addition to weekly hospitality)
 - Receptions following 3 funeral/memorial services
 - Active participants in Easter reception

Minutes of the Annual Meeting of the Congregation - June 5, 2016

- **I. Call To Order.** The Annual Meeting of the Congregation was called for the purpose of electing officers and receiving the Annual Report. It was called to order by Moderator Rev. Daniel deBeer at 10:50 a.m., and opened with prayer.
- **II. Election of Officers.** Brad Wolter, Session representative for the Nominating Committee, thanked the members of the committee Karen Bromley, Barb Mayer, Beth Messina, Cheryl Hover, Doug Strubel, and Danie deBeer (ex-oficio) for their work this year. He then presented the recommendations of the Nominating Committee for action by the congregation.

Mr. Wolter presented the following candidates for the office of Elder: Martha Fluharty, Carl Kreiter, and Dick Walstra to serve first 3-year terms, and Cathryn Steeves to serve a second 3-year term. There were no nominations from the floor. Nominations were closed and the candidates for office of Elder were elected on a unanimous voice vote.

Mr. Wolter then presented the following candidates for the office of Deacon: Charlie Barlow, Brenda Matson, and Erika Panichelli to serve in their first 3-year terms, and Kathy Russell to serve a second 3-year term. There were no nominations from the floor. Nominations were closed and the candidates for office of Deacon were elected on a unanimous voice vote. Mr. Wolter presented the following candidates for the office of Youth Deacon: Katherine Bromley and Paul Johnson (1-year terms). There were no nominations from the floor. Nominations were closed and the candidates for office of Youth Deacon were elected on a unanimous voice vote.

Mr. Wolter thanked all those who provided nominations or considered a call this year, and thanked the outgoing officers for their service to Fair Oaks. Elders: Amy Kuehl, Sheryl Martin, and Derek Inksetter; Deacons: Allison Santos, Karen Bromley, Jenifer Saville, Sarah Breinig and Carolyn Santos. Rev. deBeer also thanked those officers who were concluding their terms of service, and thanked the Nominating Committee for its work on behalf of the congregation.

- III. Presentation of the Annual Report. The Annual Report, a description of the church's activities for the year, financial reports, and statistical information on church membership and participation, was presented. Session members answered questions about financial information and agreed to review the Sunday morning worship schedule in light of current attendance patterns. A motion was made to receive the Annual Report. The motion carried on a unanimous voice vote.
- **VII. Adjournment:** The meeting was adjourned at 11:10, and was closed with prayer by Rev. deBeer.

Minutes of the Annual Meeting of the Corporation – February 7, 2016

- **I. Call to Order:** The meeting was called to order by Moderator Rev. Daniel deBeer at 12:20 p.m. and opened with prayer. A quorum was present.
- II. Personnel Report: Melissa Watters and Keith Harris reviewed the changes in staff and the plan for leadership in youth activities for the remainder of the program year. We are blessed with wonderfully qualified youth leaders who are committed to provide a full complement of programming throughout the spring. On a temporary basis while we are short-staffed, Meg Rift has agreed to increase her hours to full time. Many thanks to Danie, Meg, Jessica, David, Hannah, Linda and Monica for their service this year.
- III. Financial Report and Budget: Cathryn Steeves reviewed the 2015 actual expenses and the 2016 budget as approved by the Session in its January stated meeting. Budget cuts have been made across most ministry areas to minimize the use of reserve funds in the 2016 budget. Finances will be reviewed at least quarterly to monitor the 2016 income and expenditures as we proceed through the program year.
- IV. Nominating Committee: Karen Bromley reported that Bruce Matson and Ken Van Der Griend were re-elected by the Session to serve as Financial Secretary and Treasurer, respectively. The Session thanks them both for their dedicated service to Fair Oaks. Ms. Bromley then nominated Cheryl Hover to fill a current vacancy and serve a 3-year term on the Nominating Committee. There were no additional nominations and Ms. Hover was unanimously elected. The Nominating Committee welcomes nominations for candidates for the Pastoral Nominating Committee and will begin that process later in the year.
- V. Next Steps for Pastoral Call Process: Jim Heininger described the process as laid out by the presbytery and encouraged the congregation to be involved in understanding and participating in it. There are quite a number of steps and each has value in getting us to the point of calling our next installed pastor. The Session will be sharing information with the congregation as the process moves forward.

There were several questions and comments from the congregation about the overall PNC process. Members also expressed some concern that pledges were down slightly for the 2016 year. The Session agreed to keep the congregation informed about our financial status during the year.

VI. Adjournment and Prayer: The meeting was adjourned at 1:20 p.m. and was closed with prayer by Rev. deBeer.

Adult Education

A survey was conducted a year ago regarding desired content for the Sunday morning adult education hour, and the program offerings during the past year were designed to touch on many of those areas of interest. The offerings included a mix of Bible study, theological explorations, and current events. All of these were intended to engage, enlighten, and involve Fair Oaks adults as a growing community.

Steve Heller offered a monthly Old Testament Bible study utilizing an intriguing video series and follow-up discussions of selected texts. Dr. Scott Paeth led three-week discussions in both the fall and spring regarding thoughtful issues on theology and spirituality. Dick Walstra engaged participants in some challenging dialogue on Reformed theology with a five-part series centered on the acronym TULIP (total depravity, unconditional election, limited atonement, irresistible grace, and perseverance of the saints). Dick also led current event sessions on topics such as Native American culture and religion (in the context of the Dakota pipeline) and faith and politics (in the context of the fall elections).

Early planning for the year ahead is targeting more intergenerational Bible studies as a way to engage more adults in the education hour.

This happens in the Nursery, Preschool, Bridges to Worship, Discipleville Sunday school, Mid High Sunday school, Confirmation, Vacation Bible School, Logos, Adult Education, Bible Studies, and worship. HOW it happens varies in each and every setting and many, many of you have been involved in one way or another in some aspect of Christian education at Fair Oaks Presbyterian Church.

Report from the Director of Christian Education Ministries

It is with great sadness and much difficulty that I write this report at this time only two weeks from my final day with you as your Director of Christian Educational Ministries and colleague in ministry. There is so much I could say about the struggles that I have faced in these past four years, about the challenges I see that you need to face with courage, openness, and grace. But I want to tell you about the joy I have had being in ministry with you.

Your children delight me and make me feel loved and appreciated every day. As much as it wore me out each Wednesday evening at 8:30 pm, I loved Logos and the opportunity to be in community with all of you, ages 6 – 60+. There is an energy and desire to be a part of such a ministry from the moment children entered and we gathered in the Narthex to claim our first rule of Logos (You are a child of God and I will treat you that way) and our second rule of Logos (Have fun!) to the Two Outs call as the clock turned to 8:30 as we played 9-Square. The Spirit is dynamic and moving throughout our building and our people as we experience what following Jesus is all about.

You let me unleash my need and deep calling to be creative in worship through liturgy, stars, light and salt, disciple snack mix, one hundred sheep, a burning bush, and a soaring dove. You embraced my creativity and adventurous spirit in Vacation Bible School making a Marketplace full of shops and craftspeople in the Fellowship Hall and Hometown Nazareth and Joseph's Egypt came alive for all of us.

You appreciated my care and crafting of liturgy as worship services were planned, youth and children participated, and Arts were added to our Worship committee broadening our understanding of the fullness of worship. The deepest compliments on a Sunday I preached was not that the sermon was good (although I appreciate that!), but that the whole worship service was meaningful. You caught my vision and I loved it.

You shared your lives with me as I heard your stories, buried your fathers, baptized your babies (and Miss Grace), prayed at bedsides, ranted at injustices, cheered at games, clapped at shows, asked deep questions, wrestled with faith, and wept at deep sorrows. It is a privilege beyond measure. You have gifted me with your lives and I hold that treasure with gratitude and love.

There are so many people who have supported my ministry at Fair Oaks and I am truly grateful. You are all a part of me and my time at Fair Oaks.

If I was writing with pen and paper, it would be tear-stained and streaked at this point. The memories are bittersweet but I will always choose to remember the sweet.

Congregational Activities

We held the *Fair Oaks Market* in October of 2016, bringing together the congregation in a fresh way. Over \$5000 was raised for mission (split between the Senior High Mission Trip and Housing Forward) and many members sold their wares at almost 20 booths. Many thanks to Nancy Van Der Griend, Mandy Schmeling, Brenda Matson, Jeanne Johnson, Marty Woodbury, Joan Lennie and Annette deBeer for their efforts in such a successful event.

Our fifth annual *Fall Feast* was held on Sunday, November 13 from 5 – 7pm. We moved the event back to Fair Oaks in an effort to save some money (the fee had raised significantly to hold it at OPRF) and to truly make it feel like a church event. It was attended by approximately 125 adults, teens and children. Once again we had a delicious potluck dinner with hams provided by Fair Oaks (with much thanks to Charlie Mayer and Jim Rohr) and all the sides provided by the congregation.

A *Chili/Cornbread/Pie night* was held in January at the White/Ford home. Many thanks to them for hosting.

A *Progressive Dinner* was held on Saturday, April 8th with close to 60 adults attending. The Rohm-Rossa and Owen/Wolski families were kind enough to open their homes to this large group for the appetizer and dessert portions of the evening. Many thanks to Beth Messina and Wendy Owen for organizing the event.

Thanks to Brad Wolter and Charlie Mayer for resurrecting the *softball team* this spring. The team plays most Friday evenings and enjoys friendly competition with other local groups in the area along with sharing fellowship with members of the congregation.

As I finish my time on Session, I thank everyone who has ever helped with a congregational event. Moving forward, I hope someone feels called to continue organizing these events as well as coming up with fresh ideas to bring the congregation together.

Finance and Special Gifts

The Finance and Special Gifts Committee is charged with oversight of the various financial matters of the church. The committee includes members of the Session, the Church Treasurer and Financial Secretary and members at large.

For 2016, we budgeted for a \$28,700 operating deficit and planned to use reserves to cover the amount. In fact, however, we finished the year with income of approximately \$27,000. In addition, the investment portfolio posted a gain of \$10,000. As a result, we finished 2016 with operating reserves of \$200,000 and capital reserves of \$75,000. Again in 2017, we project a deficit to fund programs and capital expenditures, so we plan to transfer approximately \$40,000 to cover the deficit. Amounts were approved at the January 2017 Session meeting; the budget was then presented to the Congregation at the annual financial meeting. A copy of the Summarized Budget for 2017 is included in this annual report along with 2016 actual financial results.

For 2017, Ken Van Der Griend and Bruce Matson agreed to continue on their long-term roles of treasurer and financial secretary, respectively. We also thank them for their continued service to the church. We thank Greg Meadors, Brad Bell, and Art Smith for their work counting cash on Sunday mornings, along with Ken and Bruce.

We will again ask previous finance chair Jeff Schroeder to perform our audit for 2017 in the next few weeks. In addition, the Finance Committee continues to manage the FOPC investment portfolio with a goal to minimize investment management fees, reduce risk and increase diversification.

LOGOS

Everyone is to treat everyone else as a child of God. ~ the golden rule of LOGOS

This year we had the opportunity to teach this beloved LOGOS rule to 79 youth and children and over 30 adult leaders, as well as parents serving in the kitchen. What were all of these people doing every Wednesday afternoon? Living under the motto that "faith is caught not taught", we modeled discipleship not only to our children and youth, but to each other through Bible Study, Recreation, Family Time and Worship Arts.

We celebrated our 23 years of LOGOS ministry by hosting a LOGOS training encounter. Two wonderful women from GenOn Ministries (LOGOS parent organization) lead over 30 of us in an all day retreat. Some who attended had been a part of the group that brought LOGOS to our church 23 years ago and some had no LOGOS exposure whatsoever. Together, we reminded ourselves that nurturing people, especially young people, into an abundant life-giving relationship with God through Jesus Christ is the most important thing the church ever does. It's always good to remind ourselves WHY we are doing it!

We also learned a bit about the HOW. We learned some best practices in Godly Play/Recreation, some tips for engaging children in Bible Study, and a whole lot about the Call Process of Logos. Finally, we contemplated a new way to structure our Logos Board, with individuals coordinating each of the four parts (Bible Study, Family Time, Recreation, Worship Arts) and one Director overseeing the whole. With that in mind, the 2017/2018 Board is structured as follows:

As we wrapped up our 2016-2017 LOGOS year, we did so with some measure of sadness. We learned we would be saying good-bye to Meg Rift, our beloved Christian Education Director and spiritual backbone to our LOGOS program. MISSION COMMITTEE

The Mission Committee of Fair Oaks is charged with coordinating ongoing church mission activities, seeking out and evaluating new opportunities locally, nationally and globally, and educating and informing our congregation about these opportunities. We are happy to report that progress continues toward meeting the Mission goals to:

- concentrate our efforts to strengthen Fair Oaks' relationship with a small number of local agencies to increase the focus and impact of our mission work,
- pursue hands-on mission projects to support our monetary giving,
- enhance focus and involvement in global mission,
- coordinate and publicize mission and outreach efforts throughout the church.
- Provide a monthly insert in the church bulletin to create awareness of and participation in mission activities.

Following are examples of the good work sponsored by Fair Oaks this past year to pursue our Mission goals:

- Supported Oak Park/River Forest Food Pantry with financial contributions, volunteers, staples collected at the church and fresh produce grown in our garden. The collection of food, hygiene, cleaning supplies and paper goods at the church was enhanced this year by focusing on a particular item each month. Examples include hygiene items in November (full size shampoo /conditioner/bar soap) and baking supplies in December (Christmas Season). The annual donation to the OPRF Food Pantry was provided during the CanDO Community Fund Drive where there is a matching grant.
- Supported Housing Forward with food and volunteers for the homeless through monthly meals for the shelter services, financial contributions for the shelter and transitional housing programs including socks from our Christmas Eve White Gift offering, and, for the fourth summer hosted individuals overnight for two weeks in June as part of PADS transitional housing summer initiative.
- Supported Fraternite Notre Dame with volunteers and one meal per month for the soup kitchen, Christmas gifts for seniors, and direct financial support. This outreach included volunteering at the soup kitchen each month. Gifts from the Giving Tree were donated to Fraternite Notre Dame.
- Supported Housing Forward Prevail with volunteers and financial contributions.
- Supported Cluster Tutoring with financial contributions.
- Supported Hepzibah by providing new pairs of mittens, gloves, and hats from the Christmas Mitten Tree
- Supported Sarah's Inn for the second year, both financially and with service projects that created kid snack bags in January and mother's appreciation baskets in May.
- Supported and encouraged walkers for the CROP walk
- Contributed to One Great Hour of Sharing which supports Presbyterian Hunger Program, Disaster Assistance, and Self-Development of People.

- Sustained our partnership with the Presbyterian Church of Los Palos by providing financial support. Jennifer Walstra made a trip to Cuba in the fall of 2016. An adult mission trip to Cuba is planned for the fall of 2017.
- Continued support for missionary Janet Guyer and Presbyterian Mission
- Continued to support ministries in Thailand, providing scholarship funds for students at McGilvary School of Theology, Prince Royal's College, and Payap University.
- Provided programming at three Sundays following the worship service. In January we
 made kids' snack bags and May we assembled mom's appreciation baskets for Sarah's
 Inn. In March we held a "hands on" mission project for Sole Hope. These will be used
 by Sole Hope to make 50 pairs of shoes for children in Uganda who suffer from foot
 parasites.
- The mid high youth created 96 hygiene kits for Church World Service, donated at a Presbytery Meeting.
- Contributed to the Double Value Coupon Program at the Farmers Market, enabling low-income families to access fresh produce and increasing buyers for local farmers.

The attached Report of Mission Giving for 2016 shows all mission receipts and disbursements for the year.

The Mission Committee of Fair Oaks Presbyterian church is grateful to be part of a congregation with such a firm commitment to mission as part of the life of Fair Oaks.

The continuing goal of the PW Board is to remain a vital and relevant organization by appealing to an intergenerational group of women of the church and inviting active participation in our events. While many events in our calendar remain constant from year to year, we have an ongoing commitment to expand our programs to provide opportunities for spiritual growth. The PW Board thanks all of you for your commitment and generous support.

Property

Unlike 2015, 2016 was a quiet year for property. We did not continue our aggressive plans to update and improve the Manse and Church. Instead it was a fix only what was broke in an effort to not use reserve funds to operate the church.

Church Improvements and repairs in 2016

Some minor roof repairs were made. Painting of class rooms and furniture.

Manse Improvements and repairs in 2016

We had several issues with AC and furnace in 2016 and repairs to the 1st floor bathroom window. We replaced the vanity in the 1st floor bathroom.

In 2017 we plan on resuming our plans to improve and update the Church and Manse. We have extensive roof work on the Church's many roofs planned 2017 and 2018. Step treads in the Church are still a priority to get done in 2017. We are currently in the process of reviewing the Manse's needs in preparation for the new Pastor.

Strategic Planning

The Strategic Planning role of the Session is to ensure that we establish clear annual priorities and keep our focus on them throughout the year.

In 2016, Strategic Planning took responsibility for organizing a Mission Study Team whose job it was to assess the findings from our Congregational Assessment Tool and other insights to map out the future strategic direction for the church. The Team consisted of current Session members Jim Heininger, Angela Topel, Nancy Van Der Griend and Derek Inksetter and congregation members Wendy White, Doug Strubel, Karen Bromley, Barb Mayer, Lisa Johnson and Jane Vishneski.

The **Mission Study Team's Report** assessed a variety of different research findings to address "who we are," our priorities and challenges, and desired characteristics in a new pastor. The Team identified the congregation's top three priorities, as identified by the online survey that the Session is already working to incorporate into 2017 programs:

- Develop and implement a comprehensive strategy to reach new people and incorporate them into the life of the church
- Strengthen the process by which members are called and equipped for ministry and leadership
- Create more opportunities for people to form meaningful relationships

The MST shared that due to the congregation's strong state and ability to move forward it focused on identifying unique dynamics at FOPC that impact our work. Conclusions included how the congregation has splintered into many smaller activity focused groups not rallied around a central purpose. "We have become more focused on **HOW** things in our faith community are done, versus **WHY** (Jesus Christ as our central purpose). In some cases we have created overburdening process and drive for perfection. We need to return to the unifying **WHY**, how Christ is present in our daily lives and works through this community of faith to support one another, and others in God's creation. The report is available on the FOPC website.

The Report also identified two key issues that the Session needed to provide direction to the Pastoral Nominating Committee (PNC) to fully and confidently address questions from candidates on relevant issues. The Session sought congregational input and accepted the following two decisions:

Maintain the Manse - With the continued goal to have our pastor live in our community, FOPC will maintain the manse on Scoville Ave. as housing for a future pastor. A thorough assessment determined that even with resources gained from the sale of the manse we could not sustain a housing allowance sufficient enough to enable a future pastor to purchase their own local residence with the community's high home values and property taxes. (As background, as a church we do not pay property tax on the manse, but an individual pastor would be required to pay taxes on personally owned property.) The committee outlined important steps to ensure that the manse is properly maintained in the future.

Recognize and Accept Same-Gender Marriages - The Session agreed to follow the lead of the Presbyterian Church USA's decision to acknowledge the marriage of "two persons" and voted to accept and recognize the marriage of same gender persons at Fair Oaks. The Session received overwhelming supportive feedback from congregation members on this issue and encouragement to practice Jesus' lesson of inclusiveness.

Many thanks to Session members and the staff for their collaboration behind these key priorities.

Fair Oaks Presbyterian Church Music Ministry

The music ministry embraces the concept of service and gift sharing rather than "performing." As the church transitioned from two to one service, this past year as Director of Music Ministries at Fair Oaks was met with the challenge of making this transition as fluid as possible. As Fair Oaks is blessed with groups who have generously lent support to services in the past – the 8:30 services in particular - it was a priority to make certain that these groups continued their strong ministry.

The Chancel Choir remained a mainstay in Sunday worship, singing most Sundays during the program year. It is a blessing to work with such a talented and fun group. As budget concerns precipitated cuts in most areas, the Christmas Eve string quartet was replaced with a professional flutist, who helped create an ambiance parishioners hope for in this special service. The choir played an integral role in the "water" theme of Lent, presenting anthems that complimented the liturgy and/or sermons. The Easter service was uplifting - with choir, bells, timpani, and inhouse trumpet all joining in the celebration. The text to anthems, offertories, and most introits is now included in the bulletins as a visual enhancement to the sung word.

Our section leaders were all central to the choir maintaining a high standard, an expectation of which Fair Oaks has long been accustomed. Hannah is a joy to work with. As the organist for hymns, accompanying anthems and providing special music when needed, she is a versatile musician. I am once again indebted to Mark Sjostrom, who for the past several years has served as librarian and assistant.

In addition to my role of directing the Chancel Choir, my responsibilities included organizing and/or scheduling groups throughout the year:

Fair Oaks Brass Ensemble
Men's and Women's Choir
Clarinet Choir and Fair Oaks Ringers (under the fine direction of Linda Van Dyke)
Logos Ministry
Summer music

The younger music groups in the Logos program - two children's choirs and mid-high bells – in the capable hands of Linda van Dyke continue to play an important role in worship, as do the Encore Bells, the envy of many church bell ministries.

I enjoy complimenting worship services with different gifts or skills that are notably outside the parameters of my job description. These include playing the trumpet for hymns and solos, playing the piano for communion on occasion, arranging music for the Guitar Ensemble and Friends, and composing choral introits. This past Celebration Sunday, the Chancel Choir premiered "This is the Day."

As summer is a quarter of the worship schedule, I was delighted that many congregants of all ages stepped up to share their gifts this past summer. Various combinations of musicians provided a wide range of styles. This coming summer looks to have an exciting line up of special music as well.

Youth Ministry Report

The 2016-2017 church year was our second year of an interim period without a youth-focused staff leader. As a reminder, we had an Associate Pastor of Youth followed by an Interim Associate Pastor who left midway through the 2015-16 program year. (As a point of reference, "Youth" at FOPC is defined as those children entering 6th grade through those youth in the summer after high school.) Our search for a non-ordained interim youth position resulted in several possible candidates but we were unsuccessful in filling the position. With an eye towards the hiring of a new pastor who will take an active role in deciding how to staff our youth ministry, we made the decision to focus our energy on the fall activities and are currently planning the calendar with the adult youth group leaders.

In spite of staffing issues, many wonderful things continue to happen due to our engaged lay-leaders, involvement from our Interim Pastor Danie DeBeer and the enthusiasm of our youth. Programming includes Mid-High and Sr High youth groups, Logos, Mid-High Sunday school, Senior High mission trip, Youth Sunday, bell choirs, confirmation class and regular participation in worship services.

Youth Engagement 2016-2017:

More than 40 youth and adults went on the 2016 mission trip to the Rosebud Reservation in South Dakota, and shared pictures and stories from their trip with the congregation in August. We thank Julie Giegler and Wendy Owen for organizing the trip, and Jackie Barlow, Emil Baumbach, John Beck, Annette deBeer, Danie deBeer, Cindy Fellencer, Keith Harris, Linda Schroeder and Linda Van Dyke for accompanying, mentoring, sharing with and learning with and from our mission trip youth.

Senior High Youth Group met regularly throughout the church year with youth leaders Linda Van Dyke, Jackie Barlow, Cheryl Hover and Michael Winters. Many of our senior high youth collaborated on the Youth Sunday service in April and ended the year with a party where a newly formed Leadership Council was installed. This Council consists of youth representatives from each high school class and will help plan youth group discussion topics and activities along with adult leaders.

Mid-High Youth Group was also a vibrant youth ministry with 6 to 15 youth meeting every other week for club time at church or for outings and retreats throughout the year. Returning youth leaders Jackie Erickson, Elizabeth McVey, Rachel Tesch and Keith Harris not only participated but took on active leadership roles.

Neither of the youth group's activities would have been as successful without the continued involvement of our enthusiastic Interim Pastor, Danie DeBeer. We were very blessed to have his involvement.

Senior High Mission Trip 2017:

The upcoming mission trip has been thoughtfully planned once again by Julie Giegler and Wendy Owen, and will be commissioned on July 16. Nearly 40 youth and adults will journey together to Niagara Falls, NY. Many adults have been involved with fund raising and

organizational activities, which began with Donut Days in August 2016 and continued with spring and fall work weekends.

Our grateful thanks go to all of the dedicated youth leaders, parents who fed, drove and helped chaperone our youth group activities, the Steeves/Perkins family for opening their vacation home repeatedly to our youth groups for retreats, and the congregation and staff for their support of youth ministry. Our youth see Christ's love embodied in our church through the relationships that are nurtured and the time devoted to talking, listening, eating and laughing together.
